TERMS AND CONDITIONS

- All booths will come with one draped 6' table and two chairs. Scotch tape, Velcro, double sided sponge strips or anything that sticks is not allowed on wall or drapes. **NOTHING** is allowed to be hung, hooked or attached to the drapes in any fashion. Exhibitor is financially responsible for any damage to drapes or walls.
- To accommodate all vendors and visitors it is extremely important that all parts of your booth (including your chair) remain inside your assigned 10x10 space.
- Make It Take Its are offered by the Event in limited quantities. As a vendor if you prefer to offer the MITI in your booth, you must have a minimum of 2 booths, a maximum of 4 students at a table and the chairs/table/all supplies must be within your assigned area. No overflow into the walking area. If a crowd forms to watch we will ask that they watch from inside the booth to prevent a traffic flow issue. A maximum of \$20 may be charged - you may charge less.
- **Please do not advertise times or early sign ups for the MITI. Advertising confuses the attendees and takes away from the overall class participation.**
- Exhibitors must be in attendance in the booth at least 15 minutes prior to opening the exhibition each day. Exhibits must be attended at all times.
- Exhibits are to be fully stocked and not used solely as tabletop displays.
- No early dismantling allowed.
- No smoking, No food, No alcohol, No glitter will be allowed on the exhibition floor.
- **Sales and tax charges are the sole responsibility of the exhibitor and must be turned into the the Oklahoma Tax Commission by YOU. BEROTU is no longer able to process for you. We will supply a form copy or you may pay online. Notice from OK Tax Commission at the bottom.**
- Children who accompany exhibitors must be supervised at all times.
- Booth sharing is permitted. Please notify us who all is participating in the booth.
