Exhibitor is financially responsible for any damage to drapes or walls.
- Exhibitors must be in attendance in the booth at least 15 minutes prior to opening the exhibition each day. Exhibits must be attended at all times.
- Exhibits are to be fully stocked and not used solely as tabletop displays.
- No early dismantling allowed.
- No smoking, No food, No alcohol, No glitter will be allowed on the exhibition floor.
- Sales and tax charges are the sole responsibility of the exhibitor and must be turned into the Berotu, LLC treasurer, Janette Ward or to Katie Van Horn before departing at the end of the show.
